4.7 Communications from F.I.E.L.D. President David Villarino to SAEC - John Werner	 David Villarino was notified about SAEC Board decision not to extend partnership agreement F.I.E.L.D. was the 3rd party service provider in an agreement between COS and Siskiyous College ▶ F.I.E.L.D was notified by COS that the instructional agreement between COS and Siskiyous would not be continued into 2018/19 John Werner returned a call to David Villarino on 8/21/19 ▶ D. Villarino asked SAEC to make a recommendation to COS to keep the agreement between COS and Siskiyous College for non-credit ESL classes ■ D. Villarino expressed his anger and opposition to the non-renewal of the instructional agreement between the colleges ■ D. Villarino stated that F.I.E.L.D would offer ESL classes in the region regardless of the agreement and that someone would pay for the classes ■ D. Villarino stated that he would sue SAEC if SAEC did not make a recommendation to COS to continue the instructional agreement with Siskiyous ■ He would sue for membership in SAEC and that he believes F.I.E.L.D has a right to membership ■ He would seek an injunction and temporary restraining order ■ He stated that the agreement represents \$200,000 for F.I.E.L.D. ■ D. Villarino said that F.I.E.L.D would force the issue in court ■ J. Werner told D. Villarino that he would notify the SAEC Board at the next board meeting on 9/4/18 and that it

would be on the agenda. J. Werner confirmed with D. Villarino that D. Villarino was still receiving SAEC Board meeting notices, agendas, and packets via e-mail. D. Villarino confirmed that he was receiving them

- John Werner characterized the call as threatening
- David Villarino had also contacted Larriann Torrez prior to 8/21/19
 - ➤ D. Villarino contacted her on her cell phone and was extremely angry
 - > D. Villarino threatened to sue during the call
 - L. Torrez reminded him she works well with everyone in the community and he agreed. He calmed down at this point but after a short time went back into his "angry mode"
 - L. Torrez let him know he needed to contact John Werner and she would contact him as well
 - L. Torrez contacted her superintendent after the phone conversation
- David Villarino contacted Jennifer Vega La Serna. She shared information on F.I.E.L.D.
 - > J. Vega La Serna has worked with him since 2008
 - D. Villarino asked if he could offer ESL classes in Tulare, Tipton and Cutler-Orosi through the College of the Siskiyous a year ago
 - At that time he was told he could offer classes in Tipton
 - ➤ D. Villarino came back this year to renew the agreement and again asked for Tulare, Tipton and Cutler-Orosi
 - Jennifer approached the SAEC Leadership regarding the request and was told that SAEC already covered those areas
 - D. Villarino was told that COS would not need their services this year
 - D. Villarino then called her and was told to go back and get all the data he has, name of cities he wanted, the locations, how many students, what kind of class
 - It has been about 2 weeks and have not heard back
 - J. Vega La Serna called a couple of days ago stating she was waiting for this information and he said he would get back with her
 - Still has not heard back from him
 - During phone conversation said he was more concerned about membership in the SAEC Board and was told by someone in Sacramento that he could be a member
 - Said he would sue for membership if we did not

allow him to be a member

- He is opening a Charter High School in Tulare per his website
 - For ESL students
 - Doing work experience and taking ESL classes for High School credit
- ➤ J. Vega La Serna has notified College of Siskiyous that they are not going to proceed with classes for through them for 18/19
- John Werner stated that David Villarino was notified of the meeting and that he would be on the agenda
 - ➤ It was noted by the SAEC Board that D. Villarino was not present today
- Regarding the conversation David is referencing with CDE where he said they told him he can be a member of the adult consortium
 - A letter was sent out to organizations like F.I.E.L.D. stating they do not have a right under current California Ed Code
 - One was sent out to F.I.E.L.D. specifically
 - Membership is limited by Ed Code to County Office of Ed, school districts with vested interested in adult education, the community college that houses the institution, or an ROP serving adults

Discussion

- Need definitive information from state or an attorney giving SAEC his/her opinion based on the Education Code in writing or email that F.I.E.L.D. has no relationship with us unless we provide it to them
 - John Werner will present the Education Code and supporting documents to the issue of membership at the next board meeting
- ➤ J. Werner will contact Carolyn Zachary, Director of the Adult Education Program at the California Department of Education and regarding a presentation to the SAEC Board
 - SAEC will build readiness
- As a board we can set up procedures in by-laws or governance documents to handle these situations
- SAEC Navigators will continue community outreach regarding benefits provided through SAEC to communities
 - Navigators can present to various school committees (e.g. SSC, ELAC) or local boards
- We need to work harder to get input from our community
