 - We will look at the master schedule decision

Discussion:

- No major changes.
- Drew Sorenson Asked if Adam Peck from WIA saw anything that we can help him with or would like different. Does Fresno County has something that Tulare County should have?
 - Adam stated that we collaborate with others, but will look at it more
- It was stated that we will have our annual planning process to look at things.
 - Will look at laundry list that we want partners to be aware of
- Regarding goals and program expansion; are we projecting same growth over 3 years?
- Do we have the funding?
 - Growth target in original plan was a 3 year plan to fill in gaps in our estimated need across the region
 - It was not asked to be readdressed
 - As for funding
 - Our first year release of funding can go until June 30, 2015
 - Encumbered, then it can rollover and very likely there will be a second round of funding for next year and the year after
 - Is there a guarantee there will be money there for the next few years?
 - No
 - They took the plan we submitted and saw it needed to be spread out over 3 years. They wanted the big ideas
 - In the annual plan they gave us the details for one year.
 - We gave them an umbrella overview for the 3 years.
 - State Department of Finance will be looking at what we requested and what we spend.
 - Want to be sure we allocate correctly and responsibly.

Director and Navigator Positions

Discussion today, will take action at next meeting

• Last time position flew for 4 weeks and then 2 weeks of interviews with panel system. Do we want to continue this process?

Changes:

- Updating the job description
 - State skills needed to work with multiple Districts and Providers
 - Experience working with and reporting to a Board
- Re-calibrating the salary supports the job description changes
- Realigned with High School Principal position salary
 Stan Carrizosa and Sarah Koligian should be able to access the references and follow up on them
- Liked using the Panel process
 - Each Panel scores separately
 - Gives us more information to work with

Questions:

- Do job descriptions and salary align so that we can attract people?
- Definition of work with board is a concern not all principals have that experience
 - Stated that salary is in alignment with Principal salary
 - Would be comparable to what a Superintendent would make in a smaller district.
- So are we looking for a Superintendent from a smaller district?
 - Depends on leadership style
 - They have interaction with the Board
 - It is in the right salary range
 - Job description needs to reflect what we want so they will apply
 - Managed the Board vs Worked with Board
- Interview Process
 - Narrow things down
 - Demonstrate experience of management of large scale projects
 - Call people who have worked with them
 - Pre-screening process?
 - Feels this is important
- Longevity of position
 - It is a question mark
 - Commitment to this funding has withstood the test of time
 - Need someone who is not afraid to take on this challenge
 - We need to open and honest about this position
 - If a person works hard in this kind of position they will be picked up by

someone, because of their experience.

- Will fly this position Statewide
- Talked about job description and salary
 - Task Force will update description and bring it back to the November 3, 2015 meeting
- Do we want to fly Navigator position?
 - Wait for Director to fill Navigator positions.
- It was stated that we would like to start the process of establishing classes.
 - Need time to fly jobs.
 - CBA needs to be worked through
 - Need to start advertising
- This item will be discussed at the November meeting
