1. Opening Business / Welcome and Introductions

- Called to order by Sarah Koligian at 8:02 am
- Introductions were made and a quorum was established.

2. Approval of Minutes - February 2, 2016

- Vote: All approved, None opposed, Motion Carried

3. Public Comment

None.

4. Information Items:

4.1 Central Valley Immigrant Integration Coalition - Dr. Jesus Martinez

- Regional Network, Nonprofit organization.
- Dr. Martinez talked about DOCA
 - Helps families from all walks of life
 - Work permit, social security number
 - It is not an amnesty program
 - There is a great need but they are only able to reach a handful of families
 - Now enough people are accredited in the program
 - Looking for partnerships to help them recruit so they can proved the services for the families
 - Naturalization is having the same issues
 - Shortage of nonprofit agencies to assist them

- John Werner also reached out to San Joaquin Valley of Law regarding legal support for naturalization candidates.
 - SJVC of Law looking to expand.
 - 7,150 are eligible to naturalize.
 - 5,000 qualify for DOCA
 - Additional 18,000 could be qualified but they need to be assisted in 6 months.

Comment:

- There would be an opportunity for workshops to be presented if we are open to people being trained.
- We could train our people instead of just having workshops.
- Dr. Martinez is willing to provide information to school administrators

4.3 CAEAA Report - John Werner

- John Werner and Larriann Torrez attended.
 - John Werner spoke to a panel
 - Larriann Torrez attended a Board Meeting afterwards
- Larriann Torrez recognized John Werner for doing a great job on the panel. He represented our consortium.
- Panel of consisted consortium directors and coordinators
 - Out of 71 consortiums only 8 chose direct funding vs fiscal agent
 - Direct funding is a much faster process and they are already receiving funding
- Three community colleges participated and attended the conference
- Chris Nelson gave a report on what is happening at state level
 - Changes are on State and Block Grant website
- Maintenance of effort and capacity defined
- Base funding as a terminology
 - This is the funding they are expecting to see unless we are not meeting the criteria
 - MOE + Allocation=Base Funding in 2016.17
- Immigration panel
 - Adult Ed is a perfect setting to set this up.
- Our consortium is being looked as a model

4.2 AEBG Technical Update - John Werner

- Governors Budget 2016-17
 - June 15th is the day it is confirmed
- Statewide concern
 - We need to be sure we provide the public opportunity to provide a voice at the table.
- Preliminary Allocations
 - Out by 2.28.16
 - 500 m allocation schedule listed by consortia
 - Breakdown by apportionment schedules from 15-16
 - Legislation is clear that members are to receive, not less than what they received in 15-16
 - State will set up apportionment process beginning in May in order to meet legislative delivery dates in June and July
 - Apportionment disbursement will begin in August 2016
- Spending funds
 - AB104 Adult Ed Block Grant Program does not supersede any current state or federal legislation/regulations or current collective bargaining agreements
 - AEBG funds cannot supplant existing funding or be used to purchase items outside the 7 program areas. (Or to serve non-adult students)

Discussion

- Conversion of MOU funding into consortia based funding. Based on what district cost are, are we base lining that somewhere?
 - Legislation very clear. Apportionment we received last year is what we use this year
- Consortium has the discretion on how we spend the money
 - Section 80104 legislation and by 3 year plan as approved
 - What we send out to the districts now is what they are entitled to next year.
- Cost to run program does not change
 - Funding is run through the consortium
- Is local funding being protected?
 - Tables 3 and 5 have dollars amounts
 - protected by statute
 - Districts will have to go through the process to get those monies aligned
- Our grant will increase because funding goes through the consortium
 - We have control of 1.8 million, will go to 9.1 million
- We want to be sure MOUs are protected
- Leadership Committee will follow up
- Change of terminology

- MOE to MOC
- Maintenance of Capacity vs Maintenance of Effort
- Members may spend money from AEBG as long as it is part of plans submitted to and approved by the state.
 - Item is budgeted as an objective/activity in 15-16 plan
 - Members and the public have a chance to review or comment
 - Members gave final approval of the plan through formal vote.
- Reporting AEBG Expenditures for MOE and Consortium July/August
 - Roll money out as a 5000 type of expenditure—members responsible for providing data to consortium director
 - Expenditures by program and by object code
 - Tracking system is in place
 - By program, object codes
 - Keep track of 1000 7000
 - State will ask for high level of detail back
- AB104 Budget and Reporting
 - We have MOU in place
 - 5% Administration cap
 - RISDS structure not be part of administration cap
 - We are waiting for more updated guidance on this
 - Decision is made by LAO office and Governors Office
- Funding Opportunities
 - Ways we can grow
 - Industry-driven regional collaborative
 - Community college basic skills and student outcome transformation program
 - Educational opportunities
- 16-17 Plan Submission
 - Working on updating plan
 - Meet with leadership group
 - Due by end of April for 16-17
 - Will bring back budget to the consortia
 - Current discussion on fiscal allocation schedule
 - Would like to give flexibility to the local consortium and members
 - If we miss the dead line, allocations revert back to prior year (15-16)
- 15-16 Amendments

- We will submit any substantive updates to our plan
- State does not want changes all at one time
- Effectiveness Memo
 - Expecting memo from the state
 - Our performance for this year is being looked at
 - Are we spending money
 - Are students in classes and their WIOA performance in those classes.
 Academic gains, degrees or certificates, course completions.
 - Job placement
- Mid year student reporting
 - Due at end of year
 - Data collection
 - How many adults are we serving, unduplicated student count, no shows, non-WIOA programs, how many accessing services, how many taking classes, duplicated count, etc.
 - No report this year but will have one next year
- New: sample director job descriptions posted to AEBG website. SAEC is one of the exemplars
 - On the LEA website
 - Check out the website at aebg.ccco.edu

Update:

- 2 classes on Citizen Preparation
- 3 High School Diploma classes
- 3 ESL classes
- 1 Adult Basic Education class
- 1 Independent Studies Class
- 1 Spanish GED class
- We have had some difficulties in staffing positions
- Classes are more expensive to have than first projected
 - This year we have enough money to get things done, increased costs connected to first year implementation

Discussion

- Are charter schools getting involved
 - Not locally, but they are statewide
 - Charter and Adult Ed has been a conversation statewide
 - Charters are looking at WIOA

4.7 Certificate of Completion for Adults with Disabilities - Sarah Koligian

- We are required to serve Disabled adults if they have not received their diploma and they request the service
- There are not enough students to offer a class at each site
- Tammi Bradford talked about an 18 22 year old Transition Program
 - Will check out a program in Sanger to see how they are serving this group
- Want to initiate a pilot program
- · John Werner will check to see how many students in each district have a need
 - Think there is enough for one class
- Will add to next agenda

- Time line is too short
- Application process may be too much work for the amount of money

- Do not want to be wasteful
 - Leadership Committee will think it through and make sure it aligns with our plans
- Do any partners have projects they would like to do
 - Library has a project in mind
- Partner meetings are scheduled
- Leadership Committee will follow through to see how we can handle this
- State is pushing up deadlines so we have to shift
 - We interpret and adjust what the state does so it does not impact us negatively
 - We will comply but we should not be rushed because state changed deadline
 - Board should discuss how we will should handle deadlines that have been shortened
